BEHAVIOR GUIDANCE FORM

In order to guarantee a safe, positive and enjoyable environment for your child as well as the other children in the program, we are utilizing the following discipline plan. The camp staff has the authority and responsibility to carry out this system. Praise and recognition of good behavior are built into the everyday plan. The negative consequences have been developed in order to help each child **CHOOSE** to behave appropriately.

We are here to plan and lead activities that are **SAFE, CREATIVE, and FUN** for the children, which will give you peace of mind about their participation at the Sun Devil Kids Camp and Kids Quest Programs. Therefore, no child's behavior should interfere with our right to carry out this program, hinder another child's enjoyment of this program, nor go against the best interest either of the child or the group as a whole.

This may seem like a large undertaking, but with your support and cooperation, we will all receive very positive results.

A child's behavior is expected to be consistent with the following:

1. Use appropriate language at all times.
2. Cooperate with staff and follow directions.
3. Respect other children and staff, equipment and facilities, and yourself.
4. Maintain a positive attitude.

The Discipline Policy

1. Warning
2. Time-Out
3. If a child is unable to comply with the behavior expectations, a conference will be held with the child and the Camp Manager or, if necessary, the Program Coordinator(s). The parent/guardian will be notified in writing.
4. If, after the above meeting, that child is still unable to comply with the behavior expectations, the program coordinator(s) will set up a conference with the parent/guardian. A behavior contract will be established and signed by the child (if appropriate), parent/guardian and the program director.
5. If the child's behavior continues to be disruptive and/or unsafe, the child will be subject to suspension or dismissal.
6. Failure of the parent/guardian to attend conference(s) and cooperate will subject the child to suspension or dismissal.

Behaviors which may result in immediate dismissal include but are not limited to:

1. Any action that could threaten or poses a direct threat to the physical/emotional well-being of the child, other children or staff. This includes bullying, running away, fighting, etc...
2. Possession of a weapon of any kind
3. Vandalism or destruction of ASU property or property of others
4. Deliberate defiance of camp rules or staff instructions pertaining to the safety of the child or other children
5. Stealing

RELEASE, INDEMNITY, AND ASSUMPTION OF RISK

I consent to my child's participation in the Sun Devil Kids' Camp and Kids Quest at the Sun Devil Fitness Complex at Arizona State University; and I understand that my child's participation involves certain risks and that regardless of the precautions taken by the organization, some bodily injuries may occur. Specific risks/hazards involved in the activity include but are not limited to the following: Activities take place both indoors and outdoors, where participants are subject to a variety of risks. Activities can include such actions as running, jumping, passing, kicking, catching, throwing, and physical contact with others during participation in "contact" and "non-contact" activities. Falling, slipping, tripping, sliding, bumps, bruises, cuts, abrasions, contusions, dislocations, sprains, broken bones, pulled muscles, eye injuries, drowning, fatigue, altercations, and sunburn can potentially be part of this participation.

The likelihood of such injuries may be lessened by adhering to the following rules or procedures:

1. Understanding and following the rules of the Sun Devil Kids' Camp and Kids' Quest.
2. Follow directives of staff during Sun Devil Kids' Camp and Kids' Quest activities.
3. Report any hazardous situations to staff at Sun Devil Kids' Camp or Kids' Quest immediately.

In signing this Release, I am granting my child permission to participate in the Activity described above. This Release, Indemnity and Assumption of Risk Statement covers all events and occurrences associated with the Activity, including my child's participation and observation, including associated food and transportation. If I have any concerns about my child's health or ability to participate, I agree to discuss my concerns with my physician before deciding to allow my child to participate.

In addition, I understand and agree that the Sun Devil Kids' Camp and Kids' Quest cannot be expected to control all of the risks associated with this type of event, but may need to respond to accidents and potential emergencies. Therefore, I hereby give my consent to the provision of emergency medical treatment to the extent that the treatment is necessary in the medical opinion of the doctor rendering the treatment.

I agree to assume the cost of the risk that unexpected events may occur and result in harm, injury or illness to my child, or damage to or loss of my child's property while my child is participating in or observing the Activity. I agree to indemnify and hold harmless the Sun Devil Fitness Complex as well as ASU and not to sue the Sun Devil Fitness Complex or ASU for any costs resulting from harm or damage associated with my child's participation or observation if the harm or damage is not due to the negligence or fault of the Sun Devil Fitness Complex or ASU. I understand that my child's participation is voluntary. I have read the agreement and willingly signed for the consideration expressed and with a full understanding of its purpose for my child.

In this agreement, ASU means Arizona State University, the Arizona Board of Regents, the State of Arizona and their employees and agents.

ACKNOWLEDGEMENT AGREEMENT: *Please read and initial each line if you are in agreement. If you have questions regarding any item, feel free to contact the Camp Director, Tara Yesenski.*

_____ I acknowledge that my child is at least five years of age, having completed kindergarten.

_____ At the beginning of the day, Parents/Guardians must sign their child(ren) "in" to camp. A child may leave during camp hours on his or her own volition. If a child requests to leave, the child will be asked to sign out, and the child's parent or guardian will be contacted. At the end of the day, Parents/Guardians must sign their child(ren) "out" of camp. Please ensure that you can be reached at all times at the number you provide to us; otherwise we will endeavor to leave a message. Please note: In accordance with the policies/guidelines pertaining to the use of the MU, when in the MU, children under 12 must be accompanied by an adult who will assume responsibility for their conduct and welfare.

_____ I understand that I need to provide a lunch for my child every day.

_____ I will pay for each session of camp no later than 9am on the Monday of that session and I understand that a late fee will be charged for payment after that time.

_____ It is my responsibility to ensure that my child arrives at camp with the appropriate attire for swimming and sporting activities, including sunscreen, towel, socks and tennis shoes.

_____ I understand that camp will not be held on Memorial Day (Monday, May 28th) or Independence Day (Wednesday, July 4th).

_____ I understand that the camp's hours are 7:30am to 5:30pm, and that it is my responsibility to have my child picked up by closing time. I will be charged \$2 for every minute after 5:30pm that my child remains at camp.

_____ I acknowledge that I will not be provided a refund if my child is absent from camp for vacations, special events, short-term illnesses of four days or fewer or other personal reasons.

_____ I understand that I will be notified should my child become ill during the day and that it will be necessary to make arrangements to have my child picked up as soon as possible. If my child is exposed to a contagious disease, I agree to notify the Camp Office and I understand that my child might be restricted from camp attendance until a physician grants permission.

_____ Sun Devil Kids' Camp and the Sun Devil Fitness Complex has my authorization to use photographs, reproductions and any sound recording of my child. Such uses may include advertising and publicity purposes.

_____ I understand the Sun Devil Fitness Complex is not responsible for lost and stolen items brought to the building but, if notified, the staff will attempt to help locate missing items.
